- about 84.7 million inhabitants in 16 federal states
- capital is the city of Berlin
- whole country with an area of 357.588 km²
- Northern and Eastern Sea in the North, Lake Constance and the Alps in the South
- most Southern federal state is BAVARIA, most Northern federal state is SCHLESWIG-HOLSTEIN
- big cities: Berlin, Hamburg, Munich, Cologne, Frankfurt, Stuttgart, Düsseldorf, Leipzig, Dresden, Dortmund, Essen, Bremen, Hannover, Nürnberg...
- Germany has common borders with 9 countries
- Germany's registered unemployment rate in January 2024 was 6.1%

GERMANY's Hospitality & Tourism sector


- Very versatile structure of the Hospitality & Tourism sector:
 Seasonal and long-term contracts in the touristic regions e. g. pre-alpine regions such as Bavaria, health resorts/spas or historical sightseeing spots all over Germany, whereas more medium-term and long-term contracts in the metropolitan regions with elevated industrial activity
- <u>In very urgent need</u> of seasonal and non-seasonal staff all over the country!

GERMANY's Hospitality & Tourism sector

- Total bednight volume (guests) in 2023: 487.2 million
 - + 8,1% compared to 2022 (total of Germans and guests from abroad)
- 57 million guests from European countries, 8.1 million from America,
 6.6 million from Asia, 0,85 million from Australia / New Zealand, 0,65 million from Africa, 0,50 million from Portugal
- The ranking among the 57 million guests from European countries: NL, CH, GB, FR, IT, AT, PL, CZ, SE, DK

... and continuing to increase!



Accommodation

- For seasonal staff in the hospitality business the companies often **offer rooms or apartments** for the duration of the seasonal work.

Mostly this service must be <u>paid</u>, but it is subject to regulations, which means that the so-called "board and logging" fee (meals + drinks often included) does not exceed a certain amount (Euro 278,- monthly for a room or an apartment e.g., Euro 313,- monthly for meals + drinks -> to be taxed as a payment in kind/benefit in the employee's income tax declaration).

- **Flat renting**: the price per m² ranges from about 5 Euros to about 15 Euros all over Germany, depending on the area – metropolitan or rural, good infrastructure or not, touristic hotspot or outskirts.



Daily Cost of Living

Costs of daily consumption:

Bread 1 kg: $2 - 4 \in \mathbb{R}$ Rolls: $0,19 - 0,70 \in \mathbb{R}$

Milk 1 l: 0,95€ min. Eggs 10 pcs: 2,00€ min.

Pasta 500g: 0,85€ min. Rice: 2,29€ min.

Water (1,5l): 0,39 – 1,00€ Beer 0,5l store: 1,00€ bar: 4 € min

Cinema ticket: 10€ min. Fuel (Diesel 1I): 1,80€ variable

Electrical power: 0,30€ per kWh min.

How to trigger a job application:

- All job offers in the EURES portal include hints on how to contact the employer:
 - telefonically
 - personally (personal appearance equipped with your CV)
 - via their website
 - via e-mail
- All job offers indicate the application form the employer would like to receive.

Nice to have would be in any case:

short letter of motivation, detailed CV with educational and professional career pathways, level of German language (in case of candidates from abroad), certificates proving your qualifications and experiences

Salaries and wages:

- The German Statutory Minimum Wage from 01/01/2024:





12,41 € gross pay per hour

It is mandatory for all companies and employers not to fall below this minimum wage!



- Gross pay means that you still have to pay taxes from your wage/salary.
- According to the level of professional pre-experiences and qualifications salaries
 and wages will of course be more than 12,41 € /hour.



German labour market in general

German is an IMPORTANT precondition für a job (in most jobs).

- Helpers with experience:

A2 - B1

- Qualified professionals with vocational training or studies: B1 – C1

All sectors in Germany offer lots of vacancies:

- Car mechanics, electronical mechanics
- Logistics, storage and forwarding companies
- Construction and building companies
- IT-professionals of all kinds
